The Board of HIPH sent in a number of letters about many important and priority issues involving the member companies of the Association including, but not limited to:

- the Ministry of Development (Ms Jadwiga Emilewicz) about the publication of national annexes to Eurocode 2. We requested the implementation of next steps of actions aimed at supporting the international competitiveness of the domestic steel sector with the participation of, but not limited to, the Ministry of Infrastructure and Construction 29.11.2016.

The Polish-Czech-Slovak Meeting of the Committee on Steel, Coke, Mechanical Engineering, Energy and Environment

On 31.11 and 1.12.2016 Ustroń saw a meeting of the Polish-Czech-Slovak Committee on Steel, Coke, Mechanical Engineering, Energy and Environment. These three steel industry associations signed a joint declaration where they appealed that their governments take action aimed at sustaining the competitiveness of the steel sector. Market defences against unfair imports, rational principles of emissions trading, energy costs and MES China (Market Economy Status) are is the most important matters to be addressed nowadays.

HIPH Conference

On 1 and 2 December 2016 Ustroń saw a conference of HIPH member companies.



During the meeting issues were discussed about: the steel market, coke and refractory materials situation, EU Steel trades with third countries, T-TIP, EU trade defence instruments (TDI) modernization and the current anti-dumping and anti-subsidy proceedings in the international steel and raw material trade. The update was delivered about the possible consequences of granting the market economy status (MES) to the Peoples Republic of China, low effectiveness of currently applied EC's market protection instruments and the legal possibilities of limiting increasing imports dumped steel products from third countries.

HIPH Council Session

On 5 December 2016 the headquarters of HIPH at saw the Council session convened.

At the meeting the Board Members were updated about the steel, coke and refractory market situation after 9 months of 2016. The status of the coalition works formed with the participation of HIPH and law firms was summarised relating to the steel AD proceedings against steel imports from Belarus, and the Plan for Metallurgy. Trade defence instruments, MES China, TTIP, Energy Efficiency Law, talks with PSE on DSR, transitional fees and INNOSTAL sectoral program were discussed, too.

INNOSTAL Steel Sectoral Program

On 15 December 2016 the NCBiR National R& D Centre published a ranking list of projects for financing under the INNOSTAL scheme.

As a result of the substantive assessment 19 projects got positive assessment ratings and qualified for funding. The NCBiR decided to grant an additional amount of PLN 95 million for the second competition round in 2017 (the call for proposals is expected to take place in the third quarter of 2017).
